PAYMENT PLAN OPTIONS:

Weekly Plan: Weekly payments are due Monday of each week.

Semi-Annual Plan: A 2% discount is applied to the remaining tuition balance due on the Semi-Annual plan. This discount applies to the academic program only. The Semi-Annual plan tuition payments are due July 1, 2026, and January 1, 2027.

Annual Plan: A discount is applied to the annual tuition balance for the academic program only, based on student start date: 4% (Aug 1–Dec 1), 2% (Jan 1–May 1), and no discount beginning June 1. Annual Plan tuition is due July 1, 2026.

Tuition Rates and Payment Plan Options:

1. The preferred method for tuition payments with no additional fee is ACH debit to the designated bank account. Any payments made via credit card have an additional surcharge, which is subject to change.
2. All fees are non-refundable.
3. Requested schedule changes or withdrawals require a 30-day advance written notice to the school.

*Tuition is due no later than Monday end of day. ACH is the preferred method of payment. **Cash payments will NOT be accepted.** A late payment fee of \$25 will be assessed at noon on Tuesday. There is a late pick-up fee of \$1 per minute after the regularly scheduled pick up time. Returned checks are assessed a \$30 service charge. You have 90 days from receipt of billing to report any differences or irregularities. Family discounts: 10% off the lower tuition for full-time students only, after highest tuition paid at regular full-time rate. Additional days will be billed at a preset amount. Please check with school administration for availability and pricing.

Vacation Credit

Upon qualifying, your child is entitled to one week's vacation credit for each 12-month School Year. The vacation credit allows you not to pay tuition for your child during an absence from the School of up to five consecutive days (which days may not extend over a weekend). To qualify for a vacation credit, your child must be enrolled at the School for at least six full months prior to the start of the period of absence. To make use of a vacation credit, you must notify your Principal in writing at least two weeks in advance of the first day of the desired period of absence, except that if the absence is due to illness, you may use the credit if you provide the Principal with a physician's note prior to the close of the second day of your child's return. You may not "carry over" vacation credits from one School Year to the next. If the period of absence is less than a full week, it will still count as use of the full vacation credit. You may not use a vacation credit after you have notified us of the withdrawal of your child from the School.
